Featured Resource: O'Connor's Federal Intellectual Property Codes Plus

In preparation for our upcoming Attorney Lecture Series, we will focus the next few months on resources related to our upcoming programs. This month, we are focusing on Intellectual Property. The most essential book in dealing with Intellectual Property is the *Federal Intellectual Property Codes Plus* from O'Connor's (or Thomson Reuters if you prefer). We have the current 2019-2020 edition. Like all Codes Plus books from O'Connor's, this book provides the relevant code sections as well as full annotations. These annotations can include relevant case law, links to forms in *O'Connor's Federal Civil Forms*, additional primary information from *O'Connor's Federal Rules*, or additional secondary material from O'Connor's. The

book is divided by code section i.e. United States Code or Code of Federal Regulations, etc. It also has a full index and table of contents. Copies of the book can be made for \$0.10 a page. You can also access the entire book on our Westlaw subscription. To do this, access Westlaw through the links on Computers # 1—#4. Then select "Secondary Sources" from the menu and then scroll to the bottom to select "O'Connor's." The book will be listed there. Prints from here are also \$0.10 a page. Technology Corner: Intellectual Property Resources Online

Intellectual Property Law concerns (among other things) the means of establishing and protecting legal protections for artistic creations (music, literature, etc.), inventions and technology, and business names and symbols through copyright, patents, and trademarks/trade dress. Technology, individual creativity, and self-publishing are an increasing part of the lives of more and more people and thus the navigation of the law of intellectual property is relevant to a greater swath of the population. On November 20, 2019 at 10:00 a.m. and again on December 11, 2019 at 2:00 p.m., attorney Ira P. Domnitz will be giving a presentation on copyright and other intellectual property issues relevant to the



general public and practicing attorneys. In advance of these classes we wanted to highlight the up-to-date online intellectual property ("IP") materials available at the Fort Bend County Law Library. On Westlaw, one of our two primary online legal databases, there are many IP resources available, such as the full text of O'Connor's Federal Intellectual Property Codes Plus; IP case opinions from the U.S. Districts Courts, the Circuit Courts of Appeal, and the Supreme Court; the entirety of the U.S. Code Annotated (Title 15, Trademarks and Unfair Competition; Title 17, Copyright; Title 18, Trade Secrets; and, Title 35, Patents); Title 37 of the Code of Federal Regulations ("CFR") concerning patents, trademarks, and copyrights; all articles from over 75 IP-specific law reviews and journals; and forms from various resources. Lexis, our other primary database, also provides the same case law, U.S. Code and CFR provisions, as well as numerous IP law reviews and journals. Lexis, through the Texas Transaction Guide also has some forms. Hein Online has the CFR and an extensive collection of IP periodicals as well. Additionally, Hein has the 1st through the 9th editions of Manual of Patent Examining Procedure published by the U.S. Department of Commerce. We hope you can attend one of the lectures. Criminal Law

Anthony Carter v. The State of Texas, 575 S.W.3d 892 (Tex.App.-Amarillo 2019, pet. granted): Defendant appealed his conviction for possession of a controlled substance with intent to deliver and the 90 year sentence. Defendant operated several smoke shops and sold a product that contained fluoro-ADB, which is not expressly identified as a controlled substance by Texas statute, though several components of it "allegedly" were within Penalty Group 2-A of §481.1031(b) of the Texas Health & Safety Code. On Appeal Defendant contended that the indictment was void because it did not allege an offense. Court of Appeals overruled that issue on whether the charging instrument was "clear enough that one can identify the offense alleged" while also finding that Defendant failed to object to the defective indictment before trial, thus waiving his complaint. Defendant's issues on appeal on whether the State proved he knowingly sold a controlled substance under §481.1031(b)(5) and whether the substance he was convicted of possessing fell within that provision were also overruled. Testimony of a forensic chemist on behalf of the state was key to the issue on proof that it was a controlled substance. As to the *mens rea* issue, the court found sufficient evidence that he knowingly possessed a substance the State intended to outlaw. The Defendant also appealed on the grounds that his 90-year sentence was excessive. However, the Court of Appeals ruled he did not preserve this complaint and thus overruled the issue. Affirmed trial court judgment. Petition for discretionary review was granted on September 11, 2019.

Family Law

In the Interest of N.J.H., a Child, 575 S.W.3d 822 (Tex.App.-Houston [1st Dist.] 2018, pet. denied): Texas Dept. of Family & Protective Services sought termination of parental rights of the parents and to obtain managing conservatorship. Via an accelerated appeal the Father (as determined through a paternity proceeding) challenged the termination on factual and legal sufficiency grounds. Father tested positive for drugs on multiple occasions, had a long and current history of drug use, was convicted of domestic abuse, did not financially support all of his children, abandoned the child's mother, and has been separated from the child and had not supported him since birth. The child has thrived with his foster parents. Appeals court found the evidence factually and legally sufficient to support the finding that it was in the child's best interest to terminate the Father's parental rights. Affirmed.
